

my.t money Lottery Scheme Terms and Conditions

1. General Overview:

- 1.1 The lottery scheme is available to all my.t money customers.
- 1.2 The lottery scheme starts on 1st August 2024 and ends on 31st December 2024 (both dates inclusive) ["Lottery Period"].
- 1.3 The offer will also run from 1st August 2024 to 31st December 2024, with specific terms for this period detailed below.

2. Eligibility:

- 2.1 This lottery scheme is open to all customers registered with my.t money and having at least 1000 points within the app.
- 2.2 Lottery scheme participation is only valid for customers residing in Mauritius and Rodrigues.

3. Ticket Redemption (August-December 2024 Offer):

- 3.1 Customers can redeem one ticket for every 1000 points available on the my.t money app.
- 3.2 Participants will be informed of their participation and their lottery number via the redeemed voucher or any other means as may be prescribed by Cellplus.
- 3.3 Customers may redeem as many tickets as they wish, provided they have accumulated the required 1000 points per ticket.

4. Draw Details:

- 4.1 For the August-December 2024 period:
 - There will be 5 draws, with 1 draw each month.
 - Each draw will proclaim 25 winners for that month.
- 4.2 A winner shall not be eligible for other prizes within the same month but will still be eligible for the draws in the remaining months.
- 4.3 The draws will take place at the Mauritius Turf Club (MTC) under the supervision of a representative from the Gambling Regulatory Authority (GRA) and winners will be announced.

4.4 Draw Dates:

- 5th Sep 2024
- 4th Oct 2024
- 5th Nov 2024
- 5th Dec 2024
- 13th Jan 2025

5. **Prize Claiming:**

- 5.1 Cellplus shall use all reasonable means to contact the winners.
- 5.2 Prizes will be awarded to winners only upon presentation of proof of identity and/or any such documents/information as deemed necessary by Cellplus.
- 5.3 Prizes must be claimed within 6 months from the date winners were announced.

6. **Publicity and Personal Data:**

- 6.1 By participating, the winners grant Cellplus exclusive permission and hereby consent to use their names, characters, photographs, voices, and likenesses in the media (printed/digital) or such other promotional activities to the extent that can be reasonably expected of them and waive any claims to royalty, right, or remuneration for such use.
